## **Summary of topics for discussion December 11 9:45am:**

*The following projects are incomplete or are causing a need to review. RCM, Treasurer, Lit Distributor, and all Subcommittee Chairs are requested to attend. Epecially Ron, Kelly, Gil to discuss Raiford.*

1. ASC Audit – the report was delayed to allow the Convention to be complete. This now needs to be completed and the information compiled with report for the ASC – need volunteers to assist.
2. Policy Update – The policy update is due this month. I recommend that we compile a list of Policy Changes and issue an Addenda ONLY unless we have a volunteer to identify and summarize the addenda (from the minutes) and insert them into the Policy document. Ultimately that is what we need to do.
3. Financial Summary – this was this years planned improvement in the Policy Document. This is NOT a change in the policy, but a summary appendix that would gather all of the appropriate items together in one place. We need to do this in preparation of Incorporation.
4. Incorporation – This has more information from Region, but the team is slim without trusted servants. Need to rebuild the team and get this completed for review.
5. Use of FCACNAX donation – we need to summarize the requests from ALL subcommittees and take them as a package to see what the total is. I know of requests coming from H&I, PR & ????. Come with your proposal and we'll put them together and see how they total up.
6. It's time to start planning for the budgets for Subcommittees for 2011. These are to be voted upon in February. I've asked Dave and Herman to prepare a summary of 7<sup>th</sup> tradition donations vs. Expenses for the past year to give us some insight into what would make sense each month and what is likely to be outside our ability to support. Subcommittees are asked to review their budgets. Homegroups are asked to review the budget priorities as spelled out in Policy.

### **SPECIAL PROJECT: RAIFORD PRISON MEETING NEEDING SOME POLICY FOOTWORK:**

**Come to the Policy Subcommittee meeting before AREA if you want to talk about this at 9:45 AM Saturday 12/11/10**

I need to ask Gil & Kelly to make a presentation that is in the form of a written motion about a formal coordinator position and literature support for the Raiford Prison Meeting. There is NO motion that I can find that says how much and how long Raiford is support to receive funds. This a problem and needs to be wrapped up NOW. The homegroup Coordinator (who is that?) needs to make a motion, be clear about it, and put it up for a vote. The motion listed in these minutes is not a concrete motion for any subcommittee...it uses the word: EXAMPLES...suggesting a willingness to support a concrete motion:

**Maker:** Recovery

**Second:** A Shot of Hope

**Motion #** 1001005

**Date:** 10-9-10

**Motion:** To use Convention Overage to fund current special projects of this area before sending on to Region. (examples: Raiford, PR, H&I...)

There is a problem with the way that we are taking on a Regional Responsibility at Raiford. Any homegroup can request support. However, there is NO BUDGETARY PRECEDENT to allow any Homegroup to be fully supported by the ASC. It is a big deal to get these guys support, however, we are not alone in our desire to help them.

As I understand it, RAIFORD is a Regional Meeting, and needs a coordinator at the Regional Level to coordinate multiple areas. Regional support needs to be coordinated. True, it is on our meeting schedule and we take pride in helping them out...

However, H&I and the RCM in our area is not authorized to coordinate access or literature orders and standard DOC rules need to apply for inmate literature and guest access unless the “coordinator” informs us and the Region differently. Our area needs to establish a “coordinator” who recruits a subcommittee and hold coordination meetings outside the ASC floor.

Support requests made by the inmates can be fulfilled without any issue by any homegroup or individual who wants to support them or by taking a collection for that purpose.
