I realize that I should never have allowed myself to be talked into submitting a letter of willingness in the first place considering the amount of service I was already involved ini at the time and should have recognized the wrong motivations on everyone's part, including my own.

I will not participate in any gossip or hearsay regarding this and even though I am no longer on the committee, I am encouraging participation at the convention. I plan on attending and having a great time, enjoying the wonderful out of town speakers, the workshops, and great entertainment venues. Hope to see you there.
