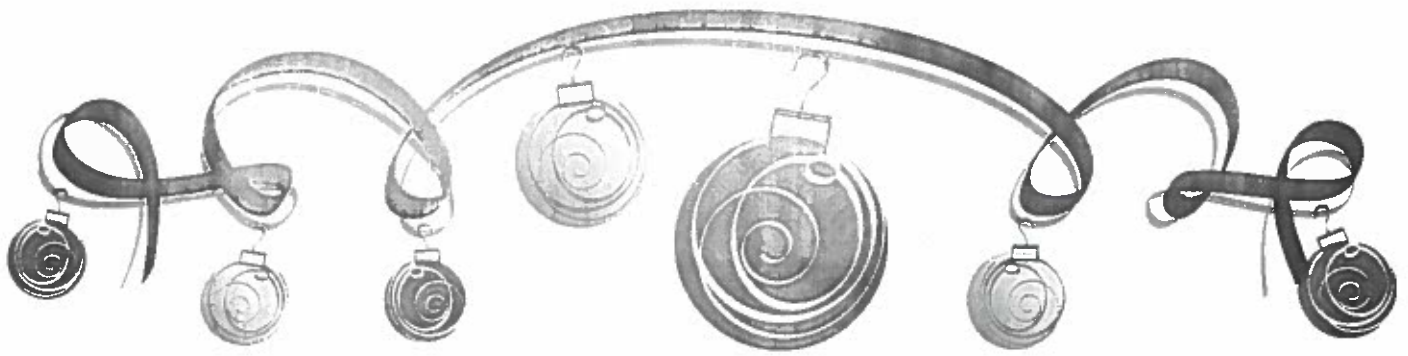
4. Directly aiding, abetting or encouraging others to engage in any of the proscribed activities set forth in paragraphs 1 to 3.

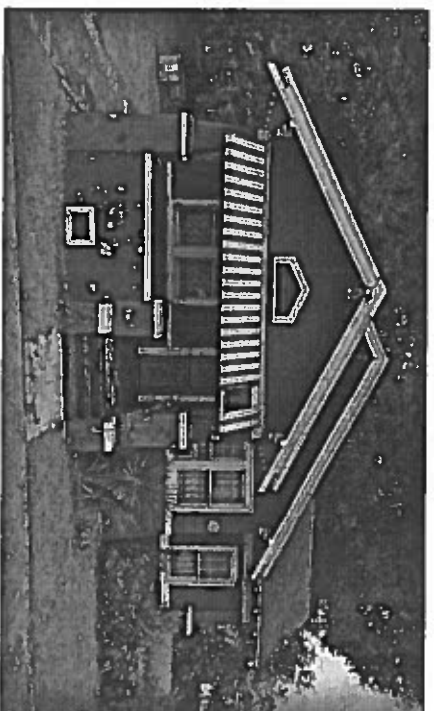
